How do I achieve PSC Master Signature Status?

PSC Signature Status must be attained before applying for Master Signature Status. Points on shows or service earned for Signature Status cannot be used for Master Signature Status. PSC Membership and dues MUST be current while earning any accumulation of status points.

Application fee for Master Signature Status: \$25.00

12 points total must be earned for Master Signature Status. 8 points must be earned in National or International juried shows for soft pastels in the professional category, and 4 points must be earned in service to the Pastel Society of Colorado. All jurors/judges must be Nationally recognized.

Award & Acceptance Points for Master Signature Status (8)

- **National or International Juried Shows** - 2 points are awarded for Best of Show, 1 point for First Place, Second place, Third place, Honorable Mention, or any other award [except People's Choice]. *1 point may also be earned for each painting accepted into the juried National or International shows with a Maximum of 2 points allowed per show (for acceptance).*
- **Awards for Plein Air** National Juried Competitions with (2 or more years history) - Only 2 points total may be earned in National Juried Plein Air Competitions. Points may be accrued for awards, points are not earned for acceptance.
- **Online** National Juried Shows - Only 2 points total may be earned in National or International Juried Online Shows. Points may be earned for acceptance and/or awards *with a Maximum of 2 points allowed per show (for acceptance).*
- **Other points** - 1 point for selection in an IAPS cover competition.
- 1 point may be earned from applicant being featured in a **National publication** such as The Pastel Journal or The Artists' Magazine. (Not an advertisement or part of an advertisement). A mention in a group editorial related to a group ad does not count.

Service points for Master Signature Status (4)

- 2 points total for service on the PSC Board of Directors: board member-1 point per year.
- 2 points total for anyone who chairs or co-chairs a show-1 point per year.
- 1 point per year for anyone serving as any other chair person, i.e.: membership, newsletter, workshops, etc. as appointed by the PSC President.
- 1 point may be earned by a demo or presentation to the PSC.
- Service Points awarded for Signature Status cannot be re-used for Master Signature Status

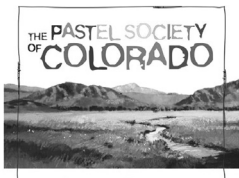

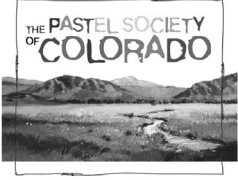
